

Privacy Policy

This Privacy Policy explains how this site treats “personal information.” “Personal Information” is information that is personally identifiable like a name, address, e-mail address, social security number or phone number, and that is not otherwise publicly available.

Categories of Personal Information Collected

- Cookies: a cookie is a small text file that is sent to your Web browser from a Web server and stored on your computer’s hard drive. When you visit this site, a cookie may be sent to your computer. Use of Personal Information Collected
